

You May Be **ELIGIBLE** If

- 1. Change in residence: Household moves that qualify are
 - Moving to a new home in a new Zip code or county
 - Moving to the U.S. from a foreign country or United States territory
 - If you're a student, moving to or from the place you attend school
- **2.** Loss of Coverage: You may qualify for a Special Enrollment Period if you or anyone in your household lost qualifying health coverage in the past 60 days OR expects to lose coverage in the next 60 days.
- **3. Got Married:** Pick a plan by the last day of the month and your coverage can start the first day of the next month.
- **4.** Had a baby, adopted a child, or placed a child for foster care: Your coverage can start the day of the event even if you enroll in the plan up to 60 days afterward.
- 5. Got divorced or legally separated and lost health insurance: Note
- Divorce or legal separation without losing coverage doesn't qualify you for a Special Enrollment Period.
